**STEP 4: Terms, Conditions and Policies**

- 1) For Daytrips, Overnights, Weekenders, Getaways and Full Monty's if you cancel 30 or more days prior to your trip date, you will receive a credit voucher less a \$50 administration fee per person (valid 1 year from departure date). Cancellations 3 to 29 days of departure receive a 50% credit voucher less a \$50 administration fee per person. Cancellations less than 3 days of departure and no shows receive no refunds or credit vouchers.
- 2) Deposits paid for Club REO vacations, Irish Dance Camp, Songwriter Retreats, Shape-Up Vacations or group & school trips are non-refundable. For cancellations, full payments are subject to the following terms: credit issued is on total after deducting non-refundable deposit; cancellations more than 30 days in advance receive full credit less deposit and \$50 per person administration fee; 7 to 29 days in advance receive 75% credit voucher less deposit and administration fee; less than 7 days receive 50% credit voucher less deposit and administration fee. No shows receive no credit.
- 3) In order to run the safest trips possible REO reserves the right to make itinerary changes. This may include changing the time of the trip or moving to another river, which may alter your itinerary and change travel times to and from the river.
- 4) If REO must cancel a trip we will refund your payments, re-schedule the trip or give a 100% credit voucher.
- 5) All guests need to fill out and sign a waiver upon arrival. Anyone 18 years and under will also need to have their waiver signed by a parent or guardian. REO enforces its resort policies to protect the well-being of all guests.
